SPECIAL INFORMATION

PATTERNS COMPETITION

This tournament will follow current ITF rules regarding Patterns. Competition is head to head, with Color Belts performing an Optional Pattern at or below their rank. Black Belts will perform an Optional Pattern (based on rank, through Moon-Moo), and a Designated Pattern (Chon-Ji through Moon-Moo, depending upon the rank of the competitors).

SPARRING COMPETITION

This tournament will follow current ITF rules regarding Sparring. Competition will be a single 2 minute round for all ranks, including the Black Belts with the exception is the Black Belt final (1 & 2 place) which will be two 2 minute rounds. Sparring is single elimination.

SPARRING EQUIPMENT

For Color Belts through Blue Belt, both current ITF regulation equipment, as well as foam-dipped equipment will be acceptable. Equipment must be in good repair, and will be inspected. The fingers may not be exposed in any way when a fist is made. Competitors found to have unacceptable equipment will have 2 minutes in which to replace their gear.

Red Belts and Black Belts must wear current ITF regulation equipment, and may borrow from other competitors if necessary. They do not need both red and blue equipment, as flags will be used to designate the fighters. Fighters' equipment will be inspected prior to their match.

Mandatory Sparring gear includes: Gloves, Boots, Headgear, Mouthpiece, Cup (males)

Optional Sparring gear includes: Shin Protectors, cloth joint protective sleeves (knee/ankle/elbow only)

Prohibited Equipment includes: Face Shields (unless the competitor provides a written mandate by their physician), Chest Protectors, any hard braces, protective eyewear of any kind. Contact Lenses are permitted.

Additional information will be announced at the umpire/rules meeting prior to the event, or dispersed via email.
